CHALLENGE

Steamboat Canal and Irrigation Company water is delivered to approximately 1,530 acres and to approximately 500 landowners through approximately 34 miles of open canals and existing pipelines. A history of flood events indicate **damage to irrigation canals** occurring every one to two years. **Urbanization** is also increasingly encroaching upon open canals, creating liability and safety risks to persons illegally entering the canal.

ISSUES:

- Compromised structural integrity of the canal banks
- Seepage from Canal affects homes with basements adjacent to canal
- Stormwater entering canal causes erosion and sedimentation
- Deteriorated structures contributing to the area's water supply and flooding issues

ADDRESSING THE CHALLENGE

The United States Department of Agriculture-Natural Resources Conservation Service (USDA-NRCS) is proposing this improvement project through the Watershed Protection and Flood Prevention Program. The Proposed Project will be sponsored by Washoe County Water Conservation District.

NRCS Watershed Protection & Flood Prevention Program: The NRCS Watershed Protection and Flood Prevention Program helps units of federal, state, local and tribal governments protect and restore watersheds. The program provides financial and technical assistance for erosion and sediment control, watershed protection, flood prevention, water quality improvement, water management, fish and wildlife habitat enhancement, recreation and hydropower.

FUNDING

Federal funds would be used to support the completion of the Proposed Project through the Watershed Protection and Flood Prevention Act (Public Law 83-566).

GOALS







PROPOSED SOLUTIONS

- Replace the SCIC Diversion Structure on the Truckee River
- Replace approximately 78,000 feet of open canal with pipelines within the existing alignments
- Replace headgate structures and add meters to monitor flows
- and regulate storm flows at rates acceptable to downstream infrastructure
- Retain open channel canal in some locations to accommodate historical stormwater flows

POTENTIAL BENEFITS


- Improve water quality to tributaries of the Truckee River
- 2 Enhance water conservation
- Improve public safety by minimizing flood risks from a potential canal breach, and eliminating the potential for people and animals to fall into the open canals


